# **COVID-19 RESTRICTIONS**

## **VENDORS**

Vendors will be allowed to attend sales and represent their stock providing they abide by the following:-

- 1) Maximum 2 vendor family members per consignment of stock. (no onlookers please)
- 2) Vendors may stand by their pens before the sale but must respect social distancing.
- 3) Vendors can follow their stock to the sale ring and show their animals as normal.
- 4) Vendors must leave the sale ring immediately after the sale of their stock and not return.
- 5) Vendors wishing to deduct luck money can do so **in the office immediately** after selling.
- 6) Vendors must maintain social distancing at all times.

## **PURCHASERS**

- 1) Purchasers must pre-register with the office of their intention to attend & collect a wristband on arrival to allow access to the sale ring.
- 2) Pre-sale viewing of stock will be allowed providing social distancing is maintained.
- 3) In the sale ring social distancing must be strictly adhered to.
- 4) Only one purchaser per farm to attend the sale ring at any one time. (no extra family members or onlookers please)

**These rules are designed to allow us to maximise the number of buyers in the sale ring and it is in the vendors' own interest to see this happens at all times**

The use of “Substitutes” for entered sheep is to be allowed at this sale, provided all details of the substitute sheep are lodged with the Auction Mart and displayed on the Vendors pen.

### ASSOCIATION SALE RULES

1. The Show and Sale are confined to Crowned Ewes, Gimmer Shearlings and Gimmer Lambs, the property of Registered Members of the S.S.B.A.
2. All sheep to be sold individually. All ewes to be in lamb to a Registered Swaledale Ram.
3. The Association reserves the right to limit numbers if oversubscribed.
4. All sheep to be scanned on arrival and prior to entering either the show or sale. Any ewes scanned barren, or with dead or malformed lambs to be withdrawn. The Association gives no guarantee that ewes will lamb or produce live lambs. Any sheep not scanned on the day of the sale will not be allowed to be shown, or sold through the ring at this sale. This to be strictly adhered to.
5. The Association does not guarantee that all entries will be forward.
6. All sheep to pass through the sale ring. No sheep to be sold privately unless it has already passed through the sale ring. All private sales on the premises must be booked through the mart.
7. Sale numbers on all sheep must correspond with ear tag numbers or purchaser will have the right to annul the sale. This to apply before the animal leaves the mart. The vendor to be responsible to see that the catalogue information is correct and that any inaccuracies be announced at time of sale.
8. All ewes sold as correct in mouth and udder unless stated at time of sale. The purchaser must inform the Association of unsoundness before removing the sheep from the mart.
9. All entries to be received by the date stated on the entry form or will not be accepted.
10. All prize winning sheep to be bona-fide sold in the ring, if not the prize will revert to the next animal placed by the judges.
11. The decision of the judges shall be final and all disputes shall be settled by the Association.
12. All sheep to be paid for to Hawes Farmers’ Auction Mart before leaving the mart.
13. 5.0p in the £ commission will be charged if sold, of which 1.0p in the £ is for the Association.
